In this role, you will represent the interests of the UK pet food industry promoting a responsible and sustainable industry whilst driving an appropriate and relevant regulatory framework alongside compliance for members.

This is an exciting role, which will give the right individual an unparalleled opportunity to influence the development and direction of the industry they will represent, and to shape UK Pet Food's technical services for the future. Depending on experience and expertise there is flexibility for the successful candidate to shape and develop the role.

## Background:

UK Pet Food is the industry body representing the UK pet food sector. Our 100 plus members feed 90% of the nation's pets.

# **Responsibilities:**

#### **Technical & Regulatory Support to Members**

- Acquire, maintain & share relevant knowledge to advise members on technical and regulatory issues as an industry expert.
- Keep members informed of technical and regulatory issues and developments including food feed labelling legislation (including product communications), Undesirable Substances, Feed Materials & Trade, Additives. Develop supporting guidance as needed.

Consolidate industry views on official Govt consultations.
Horizon scanning to anticipate potential future issues that could affect the feed sector from feed legislative change, transversal legislative change, and emerging issues.
<ul> <li>Run UK Pet Food's technical committees (Safety &amp; Standards Committee &amp; Raw Pet Food Group). Organising regular committee meetings in collaboration with committee chairs. Carry forward and follow through on actions, as agreed during meetings, within the agreed timeframe.</li> </ul>
<ul> <li>Support other UK Pet Food's committees when technical insight is needed e.g., Sustainability Committee (on packaging regulations) &amp; the Retailer Liaison Group.</li> </ul>

- A proven track record in developing and nurturing relationships with a range of stakeholders at a range of levels.
- The ability to manage technical issues with tangible outcomes.
- The ability to work individually and as a team player.

- Capability to add value to an organisation.
- Enthusiasm to push forward and innovate.
- The flexibility to work in a small team with an all-hands-on deck attitude when needed.
